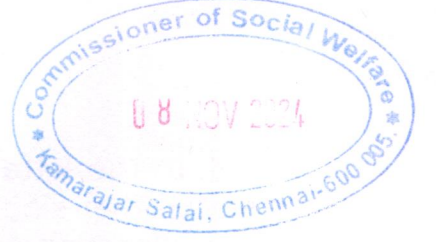

ORDER: -

The Hon'ble Minister for Social Welfare - Women Empowerment while moving the demand for grant of Social Welfare and Women Empowerment Department on 21.04.2022 has made the following announcement on the floor of the Tamil Nadu Legislative Assembly: -

"112.83 கோடி ரூபாய் மதிப்பீட்டில் 2100 பள்ளி சத்துணவு மையங்களுக்கு ஊரக வளர்ச்சித் துறையின் மூலம் வைப்பறையுடன் கூடிய சமையலறைகள் கட்டப்படும்"

2. In order to implementation of the above announcement made by the Hon'ble Minister for Social Welfare-Women Empowerment, in the Government Order 1st read above, administrative sanction has been accorded for construction of 2100 Kitchen cum Stores buildings in a phased manner at a cost of Rs.173.26 Crore (Rupees One hundred seventy three crore and twenty six lakh only). The Government also accord administrative sanction for construction of 300 Kitchen cum Stores at a sum of Rs.25.76 crore for the financial year 2023-2024.

3. In the letter 2nd read above, the Commissioner of Social Welfare has stated that since the said orders were issued only during March 2024, no fund allocation / financial sanction has been sought for during the year 2023-2024. However, these 300 number of Kitchen Cum Stores building works would be taken up during the financial year 2024-2025. Therefore, the Commissioner of Social Welfare has requested the Government to sanction and release a sum of Rs.25.76 crore for construction of 300 Kitchen cum Stores and to undertake above construction work during the current financial year 2024-2025.

4. In the Government Order 3rd read above, an amount of Rs.25.76 crore have been sanctioned for construction of 300 Kitchen cum Stores for the year 2024-2025.

5. The Commissioner of Social Welfare in the letter 4th read above has now sent a proposal for construction of 700 kitchen cum stores during the financial year 2024-2025 and requested to sanction a sum of Rs.55.64 crore in addition to Rs.25.76 crore for the construction of 300 Kitchen cum Stores which were allotted for the year 2023-2024.

6. The total estimated cost for construction of 2100 Kitchen cum stores works out to Rs.173.26 Crore. Out of which, the Commissioner of Rural Development and Panchayat Raj Department has agreed to bear the additional requirement of Rs.60.26 Crore for the construction of 2100 Kitchen cum Stores. Therefore, the Rural Development and Panchayat Raj Department will release Rs.60.26 crore as it's share.

7. The Government after a detailed examination, accord sanction for a sum of Rs.55,64,00,000/- (Rupees fifty five crore and sixty four lakh only) for the financial year 2024-2025 towards construction of 700 Kitchen cum Stores in a phased manner.

8. The expenditure sanctioned in Para 7 above shall be debited to the following head of account:

"4236 - Capital Outlay on Nutrition 80- General 800 Other Expenditure - State's Expenditure - UA Construction of Kitchen cum stores -416 Major works -01-Major works"

(IFHRMS DPC: 4236 80 800 UA 41601).

9. Necessary additional funds of Rs.55,64,00,000/- will be provided in the RE/FMA 2024-2025. Pending provision of such funds, the Commissioner of Social Welfare is authorized to incur the expenditure sanctioned in Para 7 above. She is also directed to include this item of expenditure while sending the proposal for RE/FMA 2024-2025 to Government in Finance (SW) Department without fail. However, this expenditure shall be brought to the notice of Legislature by Specific Inclusion in the supplementary estimates 2024-2025. The Commissioner of Social Welfare shall also send necessary draft explanatory notes to Government in Finance (SW/BG-I) Department for inclusion of this Expenditure in the supplementary estimates 2024-2025 at the appropriate time without fail.

10. This order issues with the concurrence of Finance Department vide its U.O.No.7465526 /Finance (SW)/2024, dated 05.11.2024 and Additional Sanction Ledger Number 1286(One thousand, two hundred and eighty six) (IFHRMS ASL No.2024111286).
