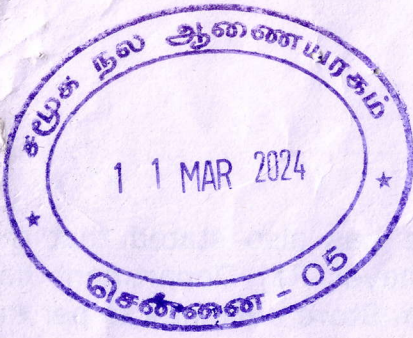

ORDER: -

The Hon'ble Minister for Social Welfare and Women Empowerment while moving the demand for grant of Social Welfare and Women Empowerment Department on 21.04.2022 has made the following announcement on the floor of the Tamil Nadu Legislative Assembly:-

"112.83 கோடி ரூபாய் மதிப்பீட்டில் 2100 பள்ளி சத்துணவு மையங்களுக்கு ஊரக வளர்ச்சித் துறையின் மூலம் வைப்பறையுடன் கூடிய சமையலறைகள் கட்டப்படும்"

2. As per the announcement made by the Hon'ble Minister for Social Welfare Women Empowerment, the Commissioner of Social Welfare in the letter 4th read above has sent proposal for construction of 2100 Kitchen cum Store buildings in a phased manner consisting 3 phases i.e., 2023-2024, 2024-2025 and 2025-2026.

3. The Commissioner of Social Welfare has also stated that the Commissioner of Rural Development and Panchayat Raj Department has proposed that a total number of 2100 Kitchen cum Store buildings as per the announcement made by the Hon'ble Minister may be taken up and completed by the Department. Further, the total amount required would be Rs.173.26 crore for the construction of 2100 Kitchen cum Store buildings in Nutritious Meal Centres and furnished the revised type designs for Kitchen shed buildings incorporating additional store room due to which the proposed plan area has increased. As per the revised plan adopted by the Rural Development and Panchayat Raj Department, fund requirement for undertaking the construction of 2,100 Noon Meal Centres has been worked out as detailed below:-

4. The Commissioner of Rural Development and Panchayat Raj Department in his letter 3rd read above has requested to release a sum of Rs.113 crore for the construction of 2100 Kitchen cum Store buildings stating that the additional requirement of Rs.60.26 crore would be borne by the Rural Development and Panchayat Raj Department from other State / Union Schemes for the financial year 2023-2024.

5. The Commissioner of Social Welfare has therefore requested the Government to consider the proposal of the Commissioner of Rural Development and Panchayat Raj Department and issue suitable orders to implement the construction of 700 Kitchen cum Stores each in the next three financial years and to authorize to sub allocate the works to different districts based on the urgency, land availability and pending works in hand and to release a sum of Rs.173.26 crore for construction of 2100 Kitchen cum Stores for the year 2023-2024.

6. The Government after detailed consideration, accord administrative sanction for construction of 2100 Kitchen cum Store buildings in a phased manner at a cost of 173.26 crore (Rupees one hundred seventy three crore and twenty six lakh only). The Government also accord administrative sanction for 300 Kitchen cum Stores at a sum of Rs.25.76 crore (Rupees twenty five crore and seventy six lakh only) for the ~~year~~ financial year 2023-2024.

7. The Commissioner of Social Welfare is permitted to carry out the construction of 2,100 Kitchen cum Stores as per the schedule of rates prescribed by the Department of Rural Development and Panchayat Raj as detailed below:-

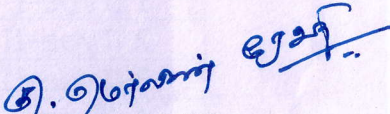
