ORDER:-

The Hon'ble Minister for Social Welfare has made the following announcement on the floor of Assembly on 21.06.2024:-

"to procure and supply egg peeler machines to 451 Noon Meal Centres where the benefitting strength is more than 500 at a total cost of around Rs.9.00 crores".

2. In the letter 2nd read above, the Commissioner of Social Welfare has submitted the proposal to procure and supply of egg peeler machines to the 451 Noon Meal Centres where the benefitting strength is more than 500 at a total cost of Rs.9.00 crores. The Commissioner of Social Welfare has also stated that the Tamil Nadu Government is providing egg as supplementary nutrition along with hot cooked meal 5 days a week to the children benefitted under Nutritious Meal Programme in Government and Government Aided schools all over the State. Among the said schools, most of the schools are having more than 500 children beneficiaries and due to the handling of huge quantity of boiled egg, peeling process consumes major part of human resource while serving of hot cooked meal. The eggs are not only boiled but also prepared and served as

variety masala eggs according to the weekly menu as detailed below and this process takes additional time and hard labour:-

3. The Commissioner of Social Welfare has therefore requested the Government to issue necessary sanction orders for the procurement of 451 Industrial grade Egg peelers through GeM portal at a total cost of Rs.9.00 crore (Rupees Nine crore only) for the purpose of implementation of the project in 451 schools in Tamil Nadu and also requested to issue necessary orders for procurement of 10 Industrial grade Egg peelers through GeM portal on pilot basis in 10 schools in 3 district namely Chennai, Kancheepuram and Tiruvallur.

4. The Government after careful examination of the proposal of the Commissioner of Social Welfare, accord sanction for a sum of Rs.50,00,000/- (Fifty lakh only) to procure egg peelers on pilot basis on 5 schools per District in Thoothukudi, Chengalpattu, Thanjavur, Krishnagiri, and Erode Districts (Rs. 2 lakh per unit in 25 schools) through e-procurement in NIC portal.

5. The amount sanctioned in Para 4 above shall be debited under the following head of account:

"2236 Nutrition - 02 - distribution of food nutritious and beverages
102 - Mid Day Meals State's expenditure - AX Replacement of Vessels under Puratchi thalaivar MGR Nutritious Meal Programme -
324 Material and Supplies - 01 Materials and Supplies "

6. Necessary additional funds of Rs.50,00,000/- will be provided in the RE/FMA 2024-2025. Additional provision of such funds, the Commissioner of Social Welfare is authorized to draw and disburse the amount sanctioned in Paragraph-4 above. However this expenditure shall be brought to the notice of Legislature by a specific inclusion in the Supplementary Estimates 2024-2025. The Commissioner of Social Welfare

shall include this additional expenditure while sending the proposal to the Government in Finance (SW) Department for inclusion in RE/FMA 2024-2025 and necessary draft explanatory notes to Government in Finance (SW/BG-I) Department for inclusion in the Supplementary Estimates 2024-2025.

7. The Commissioner of Social Welfare is authorized to draw and incur the amount sanctioned in paragraph -4 above.
