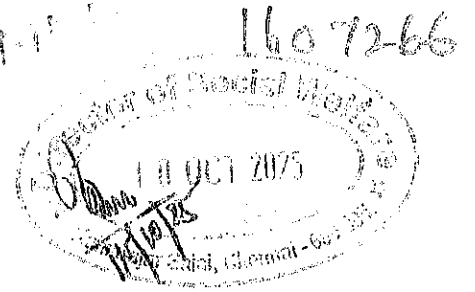




ABSTRACT



Social Welfare and Women Empowerment Department - Puratchi Thalaivar MGR Nutritious Meal Programme - Procurement and supply of eggs to the beneficiaries of Puratchi Thalaivar MGR Nutritious Meal Programme and Integrated Child Development Services - Permission to the Director cum Mission Director, Integrated Child Development Services to float State Level Regional Tender for procurement and supply of AGMARK quality eggs (hen) for the period from 09.12.2025 to 08.12.2026- Orders issued.

ORDER:-

In the Government Order first read above, orders were issued among others, introducing State Level Regional Tender System and the Director cum Mission Director, Integrated Child Development Services was permitted to float State Level Regional Tender for procurement of AGMARK quality eggs (hen) under Puratchi Thalaivar M.G.R. Nutritious Meal Programme and Integrated Child Development Services for a period of one year by following the provisions contained in Tamil Nadu Transparency in Tenders Act, 1998 and Rules, 2000.

2. In the Government Order second read above, orders were issued permitting the Director cum Mission Director, Integrated Child Development Services to float State Level Regional Tender and to finalize the tender for Procurement and supply of AGMARK quality eggs (hen) for beneficiaries under Puratchi Thalaivar M.G.R. Nutritious Meal Programme and Integrated Child Development Services Scheme for a period of one

year from 01.11.2024 to 31.10.2025 by following the terms and conditions laid down in G.O first read above as well as the provisor contained in Tamil Nadu Transparency in Tenders Act, 1998 and Rules 2000 and to follow the instructions issued in G.O.(Ms) No.94, Finance (Salaries) Department, dated 30.03.2023. Based on the above said G.Os, the State Level Regional Tender for the procurement of eggs was floated on 16.10.2024 by the Director cum Mission Director, Integrated Child Development Services.

3. In the Government Letter third read above, the Commissioner of Social Welfare was permitted to extend the existing contract entered between the Commissioner of Social Welfare and egg suppliers for a further period of two months, i.e., November and December 2024 or till the finalization of the tender process, whichever is earlier with the present contract rate of Rs.5.80 per egg, including transportation and overhead charges at the same terms and conditions stipulated in the tender for the year 2023 for supply of eggs to the beneficiaries of Puratchi Thalaivar M.G.R. Nutritious Meal Programme and Integrated Child Development Services as the existing agreement for supply of eggs had ended on 31.10.2024 as the minimum time required for the new tender works carried out during the tender process may take two months. The Commissioner of Social Welfare has extended the contract period accordingly.

4. In the letter 4th read above, the Director cum Mission Director, Integrated Child Development Services has stated that the tender was finalized on 06.12.2024 and the selected contractors are supplying eggs to PTMGR Nutritious Meal Programme and Integrated Child Development Services centres from 09.12.2024. She also stated that the contract period for supply of eggs is only upto 08.12.2025. Hence, a fresh State Level Regional Tender for procurement and supply of eggs for beneficiaries under Nutritious Meal Programme and Integrated Child Development Services Scheme has to be floated at the earliest i.e., during October 2025.

5. The Director cum Mission Director, Integrated Child Development Services has requested the Government to issue necessary orders permitting the Director cum Mission Director, Integrated Child Development Services for floating new State Level Regional Tender and finalizing the rate per egg for procurement of eggs for beneficiaries under Nutritious Meal Programme and Integrated Child Development Services for a period of one year from 09.12.2025 to 08.12.2026 and to permit the Director of Social Welfare to enter into agreement with the selected contractors for the supply of eggs under PTMGR Nutritious Meal Programme and Integrated Child Development Services scheme for a period of one year from 09.12.2025 to 08.12.2026.

6. The Government, after careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, have decided to permit the Director cum Mission Director, Integrated Child Development Services to float State Level Regional Tender and

finalize the tender for procurement of eggs (hen) for beneficiaries under PTMGR Nutritious Meal Programme and Integrated Child Development Services scheme for a period of one year from 09.12.2025 to 08.12.2026 by following the terms and conditions laid down in the G.O first read above as well as the provisions contained in Tamil Nadu Transparency in Tenders Act, 1998 and Rules 2000 and the instructions issued in G.O (Ms) No.94, Finance (Salaries) Department, dated 30.03.2023 and to permit the Director of Social Welfare to enter into agreement with the selected contractors for the supply of eggs under PTMGR Nutritious Meal Programme and Integrated Child Development Services scheme for a period of one year from 09.12.2025 to 08.12.2026.

7. This order issues with the concurrence of Finance Department vide its U.O.No.11568387/Fin(SW)/2025, dated 15.09.2025.
