ORDER:-

In the Government Order first read above, orders were issued towards procurement and supply of eggs to the beneficiaries of Puratchi Thalaivar M.G.R. Nutritious Meal Programme and Integrated Child Development Services Scheme for the period from 01.11.2023 to 31.10.2024.

2. In the letters second read above, the Commissioner of Social Welfare has stated that the Director of Children Welfare and Special Services Department has requested to provide five eggs a week to the children of Government Children Homes, Observation Homes, Place of Safety and Special Homes functioning under the control of Department of Children Welfare and Special Services and has informed the inability to provide funds

for the expenditure with respect to supply of eggs to children of the above said Homes. The details of Homes and number of eggs required in total are as follows:-

3. The Commissioner of Social Welfare has requested to provide eggs to the children of Government Children Homes, Observation Homes, Place of Safety and Special Homes under the control of Department of Children Welfare and Special Services and Government Service Homes under the control of Department of Social Welfare by utilizing the available funds allocated towards the supply of eggs under PTMGR Nutritious Meal Programme considering the best interest of the children envisaged in the Juvenile Justice (Care and Protection of Children) Act, 2015 and towards improving the nutritional status of the above children.

4. The Government have examined the proposal of the Commissioner of Social Welfare carefully and issue orders for supply of eggs to the beneficiaries of Government Children Homes, Observation Homes, Place of Safety and Special Homes functioning under the control of Department of Children Welfare and Special Services and Government Service Homes functioning under the control of Department of Social Welfare by utilizing the funds already provided for supply of eggs to Puratchi Thalaivar M.G.R. Nutritious Meal Programme.

5. The Government also instruct the egg suppliers of Region I to Region IV under Puratchi Thalaivar MGR Nutritious Meal Programme to supply eggs to the children of Government Children Homes, Observation Homes, Place of Safety and Special Homes functioning under the control of Department of Children Welfare and Special Services and Government Service Homes functioning under the control of Department of Social Welfare in their respective regions based on the indent given every month. The Egg suppliers are also instructed to submit the bills for the eggs supplied to the said Homes to the respective Personal Assistant (NMP) to Collectors every month along with the bills for NMP Centres. Further, the Personal Assistant (NMP) to Collectors are instructed to accept the bills for the eggs supplied to the said Homes and submit to the Commissionerate of Social Welfare along with the bills for NMP Centres.

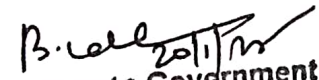
