ORDER:

As per Section 33(i) of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016), "the appropriate Government shall identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the provisions of section 34" of the said act.

2. In the note second read above, the Social Welfare and Women Empowerment Department has requested to identify the following categories of disabilities as suitable for the post of Noon Meal Organizer, Cook and Cook Assistant, Anganwadi Worker / Mini Anganwadi Worker and Anganwadi Helper:-

SL. No.	Name of the Post	Recommendation of the Social Welfare and Women Empowerment Department
1	a) Noon Meal Organizer	Only 40-50% of Locomotor Disability.
	b) Noon Meal Cook and Noon Meal Assistant	Full exemption

2	Anganwadi Worker / Mini Anganwadi Worker and Anganwadi Helper	Full exemption

3. During the Expert Committee meetings held on 13.01.2025 and 24.01.2025, the Committee accepted to recommend certain categories of disabilities as suitable for Differently Abled Persons in respect of Social Welfare and Women Empowerment Departments posts namely Noon Meal Organizer, Cook and Cook Assistant, Anganwadi Worker / Mini Anganwadi Worker and Anganwadi Helper.

4. The Government, after careful examination and based on the recommendation of the Expert Committee, decided to identify the following disability categories as suitable for the post of Noon Meal Organizer, Cook and Cook Assistant, Anganwadi Worker / Mini Anganwadi Worker and Anganwadi Helper in Social Welfare and Women Empowerment Department: -

1.	a) Noon Meal Organizer	Low Vision (LV) corrected with Spectacles Hard of Hearing (HH) corrected with hearing aid Dwarfism (Dw) Acid Attack Victims (AAV) Locomotor Disability (LD) (OL & OA with 40-80%, Both legs affected and using appropriate assistive devices for independent mobility, like crutches together with 3 wheeled scooter) Leprosy Cured (LC) (40%, no deformity in both upper limbs, with intact sensory and motor components). (only female candidates)
	b) Noon Meal Cook and Noon Meal Cook Assistant	Low Vision corrected with Spectacles Locomotor Disability (OL) Leprosy Cured (40%, no deformity in both upper limbs, with intact sensory and motor components) Acid Attack Victims Specific Learning Disability (Mild) (only female candidates)
